

ORDINANCE NO. 80-10

AN AMENDMENT TO ORDINANCE NO. 70-5

AN AMENDMENT TO AN ORDINANCE OF THE CITY OF RUSSELLVILLE, KENTUCKY, ESTABLISHING A DEPARTMENT OF SANITATION AND AUTHORIZING SUCH DEPARTMENT TO ADOPT REGULATIONS FOR A SOLID WASTE DISPOSAL SYSTEM, PROVIDING FOR PERSONAL SERVICE CONTRACTS FOR THE OPERATION OF A SANITARY LANDFILL AND PICK UP OF SOLID WASTE MATERIALS WITHIN THE CITY, BY INDEPENDENT CONTRACTORS, FIXING THE SERVICE FEE FOR SOLID WASTE COLLECTION AND DISPOSAL, PROVIDING FOR THE COLLECTION OF SAID FEE AND PROVIDING PENALTIES FOR VIOLATION HEREOF BY RAISING THE SERVICE FEE FOR SOLID WASTE COLLECTION AND DISPOSAL, PROVIDING FOR ANNUAL RAISES.

Be it ordained by the City of Russellville that Ordinance No. 70-5 be and it is hereby amended as follows:

"Section 3. For pick up and disposal of solid waste materials a monthly service fee of ~~\$3.75~~ \$5.85 for each residential unit within the City, including each apartment or mobile home or any other structure an individual or family may occupy as a dwelling place, is hereby levied against and taxed to each such residential unit. Said service fee tax shall beginning with the month of ~~April-1, 1978~~, January, 1981, be added to and become a part of the amount due on each residential water and/or sewer statement and the net amount of ~~\$3.75~~ \$5.85 shall be paid on or before the 5th day of the month following the month for which same is due. A late charge of ~~\$.37~~ \$.59 shall be added to all


monthly service fee taxes paid later than set out above making a gross of ~~\$4.12~~ \$6.44 due and owed on or after the 6th day of said following month.

If more than one residential unit is billed for water and/or sewer service on one monthly statement the number of units so served shall be multiplied by ~~\$3.75~~ \$5.85 to determine the net amount due on such water and/or sewer statement and a gross amount of ~~\$4.12~~ \$6.44 per unit shall become due and owed on or after the 6th of the following month.

Any residential unit within the City that is not billed for monthly water and/or sewer service shall for the month of ~~March, 1978,~~ January, 1981, and each month thereafter be levied and taxed a net service fee tax of ~~\$3.90~~ \$6.00 per month if paid on or before the 5th day of the following month with a gross amount of ~~\$4.27~~ \$6.59 due and owed thereafter.

In recognition of the increasing costs of doing business in this field and in recognition of the ever-changing laws governing this business, the basic charge and the late charge for each residential unit shall be increased on an annual basis in a percentage amount that is equal to the average increase in the Consumer Price Index during the twelve months immediately preceding the rate adjustment. This increase shall be determined and

shall be effective on October 1 of each year, but in no event shall any annual increase exceed eight percent unless specifically approved by the City Council of the City of Russellville."
