## ORDINANCE NO. 82-16

AN ORDINANCE SETTING THE PRICE OF GRAVE SPACES INCLUDING PERPETUAL CARE, OF OPENING AND CLOSING GRAVES ON WEEKDAYS AND HOLIDAYS AND SATURDAYS AND SUNDAYS AND FOR MAINTENANCE ON SPACES FOR WHICH PERPETUAL CARE HAS NOT BEEN PAID IN MAPLE GROVE CEMETERY WITH A SEVERABILITY AND REPEALER CLAUSE AND PROVIDING FOR THE EFFECTIVE DATE HEREOF.

Be It Ordained by the City of Russellville, that:

(1) The price of grave spaces including perpetual care at Maple Grove Cemetery shall be:

1 Grave Space	\$100.00
1/2 Lot or 5 grave spaces	\$475.00
1 Lot or 10 grave spaces	\$950.00

(2) The price of opening and closing a grave shall be as follows:

Weekdays \$150.00 Holidays and Saturdays and Sundays \$175.00

- (3) The price of maintenance on each grave space on which no perpetual care has been paid shall be \$2.00 per year, per space.
- (4) If any clause, provision or section of this ordinance shall be ruled void or unenforceable by any court of competent jurisdiction, the remainder hereof is intended to be enacted and shall be in force and effect notwithstanding.
- (5) That all ordinances, resolutions and orders, or parts thereof, in conflict with the provisions of this ordinance are, to the extent of such conflict, hereby repealed.
- (6) That this ordinance shall be effective upon its passing and publication according to law.

AN ORDINANCE ESTABLISHING THE SALE PRICE AND CONDITIONS OF SALE OF BURIAL LOTS AND BURIAL SPACES IN MAPLE GROVE CEMETERY OF THE CITY OF RUSSELLVILLE, KENTUCKY.

Be it ordained by the City Council of the City of Russellville, Kentucky as follows:

Section 1. The sale price for lots in Maple Grove Cemetery shall be as follows:

Whole lot \$200.00 One-half lot \$100.00 Single grave space \$25.00

Section 2. No lot shall be transferred to any purchaser until said purchaser has paid to the City of Russellville, Kentucky, under a previous ordinance heretofore enacted, the sum of \$200.00 for permanent upkeep for a whole lot, \$100.00 for the permanent upkeep 6f a half lot, and \$25.00 for the permanent upkeep of a single grave space.

Section 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.

Section 4. This ordinance to become effective upon passage and publication as required by law.
