

ORDINANCE NO. 92-15

AN ORDINANCE ESTABLISHING A SCHEDULE OF RATES AND CHARGES FOR THE USE OF AND SERVICES RENDERED BY THE WATER WORKS SYSTEM OF THE CITY OF RUSSELLVILLE, KENTUCKY, OUTSIDE OF THE CITY LIMITS, AND REPEALING ALL PORTIONS OF ANY PORTIONS OF ANY ORDINANCES IN CONFLICT HEREWITH TO THE EXTENT OF THAT CONFLICT ONLY, WITH WITH SEVERABILITY AND REPEALER CLAUSES AND PROVIDING FOR AN EFFECTIVE DATE

BE IT ORDAINED BY THE CITY OF RUSSELLVILLE, KENTUCKY, THAT:

WHEREAS, the Water Works System of the City of Russellville, Kentucky, is in the process of constructing an extension and improvement to the system along Highway 68-80 West and along certain other county roads in that general area; with the details of this project being set forth on the plans and maps on file in the city records:

AND WHEREAS, it is deemed advisable and necessary at this time to establish a schedule of rates and charges for the use of and services rendered by the system to these new users;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF RUSSELLVILLE THAT:

Section I. There is hereby established a schedule of rates and charges for the use of water services rendered by the Water Works System of the City of Russellville, Kentucky, outside the city limits in the area served by the Highway 68-80 Water Line Extension (1992), which shall be as follows:

(1) Installation of Water Meters:

\$440 for 5/8 inch meter
500 for 1 inch meter
600 for 1-1/2 inch meter
800 for 2 inch meter.

(2) Other Water Charges: An initial deposit of \$60.00 shall be paid as required by Ordinance 92-5. There shall be a \$40.00 reconnect fee during hours that the City Hall is open and a \$50.00 reconnect fee during hours that the City Hall is not open to reconnect any water meter that was disconnected for non-payment of charges.

(3) Monthly Water Rates:

First 1,500 gallons	\$12.00 (Minimum Bill)
Next 18,500 gallons	\$ 3.10 per 1,000 gallons
Next 30,000 gallons	\$ 2.75 per 1,000 gallons
Next 50,000 gallons	\$ 2.50 per 1,000 gallons
Next 400,000 gallons	\$ 2.25 per 1,000 gallons
Next 500,000 gallons	\$ 2.00 per 1,000 gallons
All over 1,000,000 gallons	\$ 1.45 per 1,000 gallons

(4) Monthly Minimums: The minimum monthly bills for water service shall be based upon the size of the meter serving the subject property according to the following schedule:

5/8 x 3/4	1500 gallons	\$12.00
3/4	4500 gallons	\$21.81
1	7500 gallons	\$31.62
1-1/2	15000 gallons	\$56.27
2	24000 gallons	\$85.77
3	48000 gallons	\$164.11
4	75000 gallons	\$240.43
6	150000 gallon	\$497.76

SECTION II. The foregoing revised schedule of rates and charges for the use of services rendered by the Water Works System outside of the city limits in the area served by the Highway 68-80 Water Line Extension (1992) shall be put into effect for collection on all water bills becoming due on or after September 1, 1992.

SECTION III. All portions of any section of any ordinance or rule or regulation in conflict herewith are hereby repealed to the extent of that conflict only.

SECTION IV. In the event any provision of this Ordinance is invalid for any reason, such invalidity shall not affect the validity of any other provisions.

SECTION V. This Ordinance shall be effective upon its passage and publication according to law.


