## ORDINANCE 98- 20

AN ORDINANCE AMENDING ORDINANCE NO. 80-4 "AN ORDINANCE ADOPTING THE NATIONAL ELECTRIC CODE; PROVIDING FOR THE APPOINTMENT OF AN ELECTRICAL INSPECTOR; SPECIFYING THE QUALIFICATIONS AND DUTIES OF AN ELECTRICAL INSPECTOR; REQUIRING PERMITS FOR COMMENCING CONSTRUCTION, ALTERNATIONS OR REPAIRS OF ANY ELECTRICAL WIRING AND PRESCRIBING FEES THEREFOR; AUTHORIZING ADOPTION AND AMENDMENT OF REGULATIONS IMPLEMENTING THIS ORDINANCE, AND PRESCRIBING PENALTIES FOR THE VIOLATION HEREOF" BY AMENDING THE CODE REFERENCE AND PROVIDING FOR AN EFFECTIVE DATE; WITH A SEVERABILITY CLAUSE AND A REPEALER CLAUSE

WHEREAS, the City of Russellville has previously enacted Ordinance No. 80-4 "An Ordinance Adopting the National Electric Code; Providing for the Appointment of an Electrical Inspector; Specifying the Qualifications and Duties of an Electrical Inspector; Requiring Permits for Commencing Construction, Alterations or Repairs of any Electrical Wiring and Prescribing Fees Therefore; Authorizing Adoption and Amendment of Regulations Implementing this Ordinance, and Prescribing Penalties for the Violation Hereof" and the City has determined that an amendment to same is necessary,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF RUSSELLVILLE, KENTUCKY THAT:

1. The following paragraph is amended to read as follows:

The city hereby adopts as a minimum standard, the requirements of the National Electric Code, as last published, and as hereafter amended, three copies of which shall be on file in the office of the City Clerk. In the event the Electric Plant Board of the city, the City Council, or any other governmental agency requires standards more stringent than those required by the National Electric Code, as last published and as hereafter amended, then the more stringent standards shall apply.

- 2. In the event any provision of the Ordinance is invalid for any reason, such invalidity shall not affect the validity of any other provision
- 3. All portions of any section of any ordinance or rule or regulation in conflict herewith are hereby repealed to the extent of that conflict only.
