## ORDINANCE NO. 99-7

AN ORDINANCE AMENDING ORDINANCE NO. 89-8 "AN ORDINANCE ADOPTING THE NATIONAL ELECTRIC CODE; PROVIDING FOR THE APPOINTMENT OF AN ELECTRICAL INSPECTOR; SPECIFYING THE QUALIFICATIONS AND DUTIES OF AN ELECTRICAL INSPECTOR; REQUIRING PERMITS FOR COMMENCING CONSTRUCTION, ALTERATIONS OR REPAIRS OF ANY ELECTRICAL WIRING AND PRESCRIBING FEES THEREFOR; AUTHORIZING ADOPTION AND AMENDMENT OF REGULATIONS IMPLEMENTING THIS ORDINANCE, AND PRESCRIBING PENALTIES FOR THE VIOLATION HEREOF." BY ENACTING A NEW FEE SCHEDULE AND PROVIDING AN EFFECTIVE DATE; WITH A SEVERABILITY CLAUSE AND A REPEALER CLAUSE

WHEREAS, the City of Russellville has previously enacted Ordinance No. 89-8 "An Ordinance Adopting the National Electrical Code; Providing for the Appointment of an Electrical Inspector; Specifying the Qualifications and Duties of an Electrical Inspector; Requiring Permits for Commencing Construction, Alterations or Repairs of any Electrical Wiring and Prescribing Fees Therefor; Authorizing Adoption and Amendment of Regulations Implementing this Ordinance, and Prescribing Penalties for the Violation Hereof." and the City has determined that an adjustment of the fees is necessary,

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF RUSSELLVILLE, KENTUCKY, THAT:

- I. The four (4) numbered parts of Section IV of Ordinance 89-8 shall be and are hereby amended so that they shall read as follows:

All prior Ordinance and/or regulations of the City of Russellville in conflict with the provisions of this Ordinance are hereby repealed to the extent of that conflict only, and such ordinances and/or regulations to the extent of that conflict shall cease to be effective upon the effective date of this Ordinance.
- IV. This Ordinance shall become effective upon its passage and publication according to law.
